Summary Annual Report

Iron Workers Trust Fund Local No. 5 Washington, DC, Welfare Fund

This is a summary of the annual report for the Iron Workers Trust Fund Local No. 5 Washington, DC, Welfare Fund, (Employer Identification No. 52-6057762, Plan No. 501) for the period July 1, 2021 to June 30, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The value of plan assets, after subtracting liabilities of the plan, was \$45,719,748 as of June 30, 2022 compared to \$46,717,048 as of July 1, 2021. During the plan year the plan experienced a decrease in its net assets of \$997,300. This decrease includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$11,713,331. This income included employer contributions of \$13,385,225, employee contributions of \$944,548, realized gains of \$344 from the sale of assets and earnings from investments of \$-2,616,786. Plan expenses were \$12,710,631. These expenses included \$826,840 in administrative expenses and \$11,883,791 in benefits paid to participants and beneficiaries.
